December is here. It does appear that Mother Nature is going to make it a challenge for a White Christmas this year.

we finalized the budget for 2024. While the preliminary levy was set above 20%, the final levy with persent at 2%. That said, due to a number of factors – change in ones property value, the loss of tax apacity, and a reduction in Fiscal Disparity - your final city portion of property taxes may be higher clower than the 2% levy increase.

In addition to the 2% levy increase, the Council passed a 5% increase in the storm water fee. The increase will impact the average home \$1.58 a month. The City Council and Staff will be working on riprap project at the pond's in 2024. Phase 1 was complete over a year ago which leaves Phase 2 and 3 left to do. Phase 2 is estimated to cost \$170,000 with Phase 3 being a little more than that. We will be engaging a group called Grant Watch to help seek grants to offset these costs and establishing a time line of completion to minimize the financial impact on Hamburg residents.

Rental of the Community Hall will cost non-residents \$200 more per rental in 2024. The resident cost will remain the same. Provided cost projections do not significantly change, Brad Street will be addressed in 2024 using funds from the Local Government Aid we receive from the State.





All communities in our nation are expected to do a service line inventory. The City of Hamburg would greatly appreciate your participation! Please follow the guidelines listed below:

1) Provide the Public Water System (PWS) with a clear picture of the service line and the first valve prior to the meter (preferably the side of the valve). Be sure the picture also includes the floor, foundation, or ground in which the service makes its entry from the ground. 2) If the service water line has paint, corrosion, etc., please scrape or remove such items for clear identification of the service line material prior to taking the picture. 3) If material of the service line looks gray or dark gray, please use a magnet on the service line cleaned surface. If magnet sticks to service line, please show this in your picture.



4) Please inform PWS if you have a Water Softener or Reverse Osmosis within the home.

5) When submitting your picture, please include your physical address of which the information above is provided. Please submit pictures to: publicworks@cityofhamburgmn.com. The PWS appreciates your participation in this

matter!

Winter Street Parking

Please remember that all vehicles are to be removed from the streets when there is a 2 inch or more snowfall. Streets typically are not plowed until after all the snow has settled or fallen.

Parking is allowed at Bi-Centennial Park <u>until</u> the roads have been cleared. Once the streets are plowed, we ask that you park on the street again so the parking lots can be cleared. There's a 48 Hour Parking Limit. We appreciate everyone's cooperation with this during the winter months. If a vehicle is not moved it will be ticketed and possibly towed.
