 - Council was given a handout of Commercial Inflatable Bounce Houses that could be purchased by the City for use at it's festivals. The City could also rent the Bounce House to other cities for a fee to recoup the purchase cost and for extra city income.
 - Will work on completing the NIMS training course.
 - MNSPECT will be contacted again on the Park handicap dimensions and plans.

 - City Clerk Gruenhagen will contact the County and request the cross walk be repainted on the road.
 - Mayor Malz asked members of Council if they would grant his request to attend the Chiefs Convention being held in Rochester, MN. He was able to attend the one in Duluth last year.
 - Councilmember Trebesch moved to approve Mayor Malz attending the Chiefs Convention in Rochester, MN with the City paying for the \$25 registration fee and hotel room stay during the Convention, seconded by Councilmember Odoms and motion carried with Mayor Malz abstaining.
