

Mayor Lund called the Hamburg City Council Meeting to order at 5:00 p.m. Those in attendance were: Councilmembers Jason Buckentin, Eric Poppler, Tim Tracy and Jessica Weber, City Clerk Jeremy Gruenhagen, City Attorney Kelly Dohm, and Brandon Bracht and Brad Droege.

Public Comment

Brandon Bracht, former City of Hamburg employee, discussed possible violations of 13D Open Meeting Law that have allegedly taken place by the Hamburg City Council. He talked to the person who helps cities with open meeting law (he could not remember their name) at the Data Practices Office. Brandon stated he is asking for his average wages to be paid through the end of this year from the date he was terminated, as well as vacation pay and sick pay that he would have acquired during that time in order for the city to avoid court and/or a lawsuit against the City. The violations he discussed were the two closed meetings and the one open meeting, during which time he was alleging the City violated the open meeting law. Brandon stated there was no mention of any disciplinary action against an employee (City Clerk) at the last meeting and if disciplinary action was taken you have to say what it was; if no disciplinary action you do not have to say anything. He said the City Council did things correctly if no disciplinary action was taken. Mayor Lund asked for the date and time of the meeting he is referring to. Brandon could not remember. Council provided the date as September 27, Mayor Lund confirmed there was no disciplinary action taken against the employee he was referring to (City Clerk) and therefore no violation.

Brandon said there were text messages about a public employee being terminated, which is a violation of the open meeting law. Mayor Lund asked if in his packet of documents there was mention of termination. Brandon read certain text messages. Mayor Lund asked if Brandon could confirm whether a conclusion was made as to termination. Brandon did not find any text messages confirming a decision to terminate had been reached.

Brandon asked why he wasn't placed on the agenda. City Clerk Gruenhagen informed Brandon via phone and email that agenda packets require written information to be submitted in advance. Because no written information was provided in advance as to what Brandon was asking for the City Council to take action on, he was not placed on the agenda. Mayor Lund explained that even though he was not specifically placed on the agenda, the City Council provided him more than the normal two-minute public speaking time to speak during the City Council meeting.

- Preliminary Budget currently set at 9.92%. Clerk removed \$18,000 for street seal coating and crack repairs. The next phase for the streets in the 7-year plan would start in 2024, tabled until then. Health insurance was adjusted to reflect costs in the 2023 budget.
- Wish List Items removed from 2023 Preliminary Budget:
 - Gas power pressure washer ~ \$600/removed
 - Grass lawn sweeper ~ \$400/removed
 - Shelving for shop ~ \$500/removed
 - Mulch kit ~ \$500/removed
 - Tools ~ \$3,000 reduced to \$2,000
 - Shop tool box ~ \$1,000/removed
 - Diamond dust ~ \$2,500/Removed
 - With the items removed, the Preliminary Budget was reduced 2%.
 - Council would like the max budget increase to be at 4-5%. City Clerk Gruenhagen to work on tax levy increase and provide details at next meeting.
- o 2023 City Fee Schedule
 - Suggested increase:
 - ➤ Hall rentals Increase by \$200
 - Local rentals for local businesses/benefits to \$425
 - ➤ Election Judges to \$14-\$15/Hr.
 - Water/Sewer/Storm Water Rates (Set with 2023 Budget)
 - Contact other cities for comparison on increasing accident service charges/fire call rates.
