Mayor Richard Malz called the Hamburg City Council Meeting to order at 7:00 pm. Councilmember Steve Trebesch, Councilmember Chris Lund, Councilmember Robert Gregonis, City Clerk Jeremy Gruenhagen, Deputy Clerk Tamara Bracht, and Maintenance Superintendent Greg Schultz was in attendance. Also in attendance was Fire Chief Justin Buckentin, HFD Member Steven Siewert. Council recommended Timberline WP and Donnie Dammann come to an agreement on a parcel and the City will in turn seek information from the City Engineer, Justin Black, in regards to water/sewer etc.

Fire Department Report – Chief Justin Buckentin

- New HFD Member Matt Eischens
 - **Motion:** Councilmember Robert Gregonis moved to approve Matt Eischens as a new HFD member, seconded by Councilmember Chris Lund. Motion unanimously carried. Councilmember Richard Odoms was absent.
- Fire Chiefs Convention – St. Cloud October 20th - 22nd. Three HFD members will be attending.
- MBFTE Reimbursement for Training – awarded \$4,000 in 2015 and \$1,000 last week.
- HFD Handbook/Policies – Finalized and will be sending to Council for approval.
- National Night Out - City Clerk thanked all who volunteered or donated to the event. Great turnout this year.
- City Offices – Nothing to report.
- Mayor Malz inquired about the brush pile at the ponds. Fire Chief will provide the City with a couple of numbers to call for removal. Greg Schultz will also be checking with another potential resource.

Doug Arnst – 416 Jacob Street

- Driveway flooding issues. The City Engineer, Justin Black, will be contacted to inspect the issue.

Old City Business (Memo)

- County Road Maintenance Agreement (Carver County) – nothing to report
- Water Meter Upgrades/Radio Read (Cost Estimates)
 - **Motion:** Councilmember Steve Trebesch moved to proceed with HD Supply for the purchase of a handheld radio reader, software and meters up to an \$8,000 total, seconded by Councilmember Chris Lund. Motion unanimously carried. Councilmember Richard Odoms was absent.
- Building Inspections/Code Violations
 - 411 Maria Avenue (Old City Hall) – Permit has been pulled to do replacement brick work.
 - 340 Railroad Street (Building) – Potential new buyer.
 - 153 Jacob Street (Shed) – Council recommended Mr. Buckentin work with MNSPECT to complete the siding of his shed in compliance with current code requirements.

- Steve Trebesch (419 ½ RR Street) - Cargo Storage Container - Public Hearing is on hold pending a potential land purchase from the Railroad.

Public Works & Utilities Report

- Water/Wastewater Services going well. Generators were run during storm power outage last week. One pump was able to handle the large amount of water at the lift station.
- City Shop Repairs on hold pending bids for unforeseen foundation issues.
- Community Center Roof/Bathroom Repairs – roof is leaking causing structural damage in bathrooms.
- Paint CC Parking Lot/Curbs Estimate (\$1,000) – Revisit in the Fall when street improvement project is completed.
- Mayor inquired about taking down the 4-H sign on the east end of town.
- Sewer hook-up compliance – send letters to residents not in compliance with City Ordinance. City Clerk stated the City Ordinance says there is a \$100 surcharge to be added to water bills until a homeowner becomes compliant, if not completed within one year from date of letter.

City Clerk/Treasurer Report

- Solicitor Permit (Taago Keller)
 - **Motion:** Councilmember Steve Trebesch moved to approve the Solicitor Permit. Seconded by Councilmember Robert Gregonis. Motion unanimously carried while Councilmember Richard Odoms was absent.
- US Solar (Community Solar Garden) – Council agreed to have them come to the September Council Meeting.
- Engagement Letter for GASB 67/68 Actuarial Services (HFDRA) – Cost was \$2,000 for the 2015 Audit and 2016 Audit will be \$1,000.
- Xcel Energy – Clerk is meeting with Xcel next week, will discuss old power poles on Compost Lot.
- Temporary Family Health Care Dwellings
 - **Motion:** Councilmember Chris Lund moved to opt-out of the Temporary Family Health Care Dwellings and to hold a public meeting on September 13th at 6:45 p.m. to amend the City Ordinance, seconded by Councilmember Robert Gregonis. Motion unanimously carried. Councilmember Richard Odoms was absent.
- 2040 Comprehensive Plan Update – the City can receive a Planning Assistance Grant of up to \$32,000 from the Metropolitan Council to complete the plan update.
- Health Insurance Renewal – 3.4% rate increase for 2017
- 2017 Budget Workshop Dates - Preliminary Budget is due to the County by September 30th.
